

**AUTHORIZE RETENTION OF THE LAW FIRM
BELL BOYD & LLOYD**

THE GENERAL COUNSEL REPORTS THE FOLLOWING DECISION:

Retention of the law firm Bell Boyd & Lloyd.

DESCRIPTION: The law firm Bell Boyd & Lloyd has been retained by the General Counsel to review and analyze the impact of statutory amendments governing the payment of supplemental state aid for specific educational programs and the effect, if any, caused by a change in governmental accounting rules which become applicable effective June, 2001. Authorization for the firm's fees is requested in the amount of \$30,000. As invoices are received, they will be reviewed by the General Counsel and, if satisfactory, processed for payment.


Conflicts - The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board Members during the one year period following expiration or other termination of their terms of office.

Indebtedness - The Board's Indebtedness Policy adopted July 26, 1995, (95-0726-EX3), as amended from time to time, is hereby incorporated into and made a part of the agreement.

Ethics - The Board's Ethics Code adopted September 27, 1995, (95-0927-RU3), as amended from time to time, is hereby incorporated into and made a part of the agreement.


