

APPROVE THE PARTICIPATION OF ROOSEVELT HIGH SCHOOL'S ROBOTICS TEAM IN THE 2001 FIRST ROBOTICS COMPETITION- WESTERN MICHIGAN REGIONAL AND AUTHORIZE TRAVEL AND LODGING EXPENSES RELATED TO THE PROGRAM

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve the participation of Roosevelt High School's Robotics Team in the 2001 FIRST Robotics Competition and authorize travel and lodging expenses related to the program.

PROGRAM: Twenty (20) students and thirteen (13) adults from Roosevelt High School will participate in the 2001 First Robotics Competition - Western Michigan Regional in Grand Rapids, Michigan from March 7 through March 10, 2001.

EDUCATIONAL VALUE/OUTCOMES: FIRST is an acronym that stands for "For Inspiration and Recognition of Science and Technology." The FIRST Robotics competition is a national engineering contest, which immerses high school students in the exciting world of engineering. Teaming up with engineers from businesses and universities, students get a hands-on, inside look at the engineering profession. In six intense weeks, students and engineers work together to brainstorm, design, construct and test their robot. The teams then compete in a spirited, no-hands-barred tournament complete with referees, cheerleaders and time clocks.

The partnerships developed between schools, businesses, and universities provide an exchange of resources and talent, highlighting mutual needs, building cooperation, and exposing students to new career choices. The result is a fun, exciting and stimulating environment in which all participants discover the important connection between classroom lessons and real world applications.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being made by Debbie Stern of Far Horizons at 600 Central Avenue, Ste. 245, Highland Park, IL 60035, (847) 266-2020.

Motorcoach transportation has been booked with Crown Charter Coach, 219 West 95th Street, Chicago, IL 60628. The per person cost for the bus is \$ 37.00.

A block of rooms has been reserved at the Howard Johnson Plaza, 255 28th Street SW, Grand Rapids, MI 49548. The cost per room for three nights with four (4) students to a room is \$178.20 and two (2) adults to a room is \$ 222.75.

COST: The average per person cost is \$ 190.00 which includes round-trip bus fare, all transfers and meals, lodging, health and accident insurance, trip cancellation insurance, etc. The costs will be paid by Roosevelt High School and grants. Staff and students are fund-raising to offset the costs of the trip.

CHAPERONES: Nine (9) teachers, two (2) parents, one (1) engineer and his wife will serve as chaperones.

PARENTAL CONSENT: Written parental consent and release forms for each student and chaperone are on file at Roosevelt High School.

AUTHORIZATION: [if necessary] Authorize the President and Secretary to execute any travel agreements necessary for this program.






