AMEND BOARD RULES 5-17 and 4-48**AMEND BOARD RULES:****THE GENERAL COUNSEL RECOMMENDS:**

The General Counsel recommends amending the following Board Rules:

Sec. 5-17. Non-Resident Pupils - Tuition. Pupils who live outside of Chicago and all pupils whose parents do not reside within the limits of the City of Chicago and who are staying in Chicago for the primary purpose of attending Chicago Public Schools shall be considered non-resident pupils and shall be admitted to the Chicago Public Schools only upon payment in advance to the Department of Accounting and Control of such non-resident tuition fees as may be fixed from time to time by the Board of Education. Pupils who become non-resident during a school term shall not be charged tuition for the remainder of the school term in which they become non-resident pupils. Non-resident pupils ~~may~~ shall not attend the Chicago Public Schools "magnet program," "regional gifted centers," "community academies," "specialty schools," "international baccalaureate preparatory programs," or "international baccalaureate programs, or selective enrollment high schools." Sec. 4-48. Full-Time/Part-Time Employees. Unless otherwise stated in this Chapter, the term "full-time employee" as used in this Chapter with reference to teacher certificated personnel means an employee scheduled to work a minimum of six hours per day, 30 hours per five-day work week and 60 hours per ten workday pay period exclusive of the lunch period.

Unless otherwise stated in this Chapter and with the exception of lunchroom employees ~~and school bus aides, and physicians~~ "full-time employee" as used in this Chapter with reference to education support personnel or education support personnel career service or career service exempt employees means an employee scheduled to work a minimum of seven hours per day, 35 hours per five-day work week and 70 hours per ten workday pay period exclusive of lunch period. With reference to lunchroom employees and school bus aides, the term "full-time employee" means an employee scheduled to work a minimum of four hours per day, 20 hours per five-day work week and 40 hours per ten workday pay period exclusive of the lunch period. ~~With reference to physicians, the term "full-time employee" means an employee schedule to work a minimum of three and one-half hours per day, 17 1/2 hours per five day work week and 35 hours per ten workday pay period, exclusive of the lunch period.~~ (Amended 07-31-91; 02-27-02)

Dependent upon approved job descriptions, full-time employment may be categorized as "with benefits" and "without benefits". (Amended 02-27-02)

All other categories of personnel, including but not limited to, educational support personnel scheduled to work no more than 21 hours per five-day work week and 42 hours per 10-workday pay period; outside consultants; personnel employed during the summer months; and personnel employed only for vacation periods, are considered part-time employees. (Adopted 03-24-82; Amended 02-27-02)
