APPROVE ENTERING INTO AFFILIATION AGREEMENTS WITH VARIOUS HOSPITALS

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into affiliation agreements with the 2 hospitals identified below to provide training facilities for student interns enrolled in the Licensed Practical Nursing Program at no cost to the Board. No students in the Practical Nursing program shall access either facility for training purposes prior to the execution of the written document by each participant. Written agreements are currently being negotiated. The authority granted herein shall automatically rescind as to each participant in the event a written agreement for each participant is not executed within 90 days of the date of this Board Report. Information pertinent to these agreements is stated below.

TERM: The term of each agreement shall commence on August 31, 2002 and shall end July 1, 2005. Each agreement shall have unlimited options to renew for periods of up to three years each with Board approval.

PROGAM DESCRIPTION: The Licensed Practical Nursing (LPN) Program is a two-year state approved Education-to-Careers program that encompasses both academic and clinical training. Entrance into the program begins in a student's junior year and is completed in the senior year. The program allows senior students to complete the required 240 hours of clinical experiences at area hospitals in order to obtain an Illinois Nurses Assistant Certification. Students enrolled in the LPN Program at the following nine schools will use the medical facilities at the hospitals to complete their clinical experiences: Carver, CVCA, Fenger, Gage Park, Hubbard, Hyde Park, Julian, Lindblom and Washington.

OUTCOMES: Students who successfully complete the LPN Program will be eligible to sit for the Illinois Nurses Assistant Certification exam.

COMPENSATION: None

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreements. Authorize the President and Secretary to execute the agreements.

LSC REVIEW: Local School Council approval is not applicable to this report.

GENERAL CONDITIONS:

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
