

**REQUEST FOR DISMISSAL OF LAZERICK JOHNSON, ENGINEER,  
GOODLOW MAGNET SCHOOL**

**TO THE CHICAGO BOARD OF EDUCATION**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS THE FOLLOWING:**

That this Request for Dismissal and charges and specifications preferred by the Chief Executive Officer against Lazerick Johnson be approved; that notice of his dismissal and a copy of this Board Report and accompanying charges and specifications be served upon him within ten (10) days of adoption of the Board Report.

**DESCRIPTION:**

Pursuant to Section 6 of Board Policy #95-1025-PO2 and the Rules of the Board of Education of the City of Chicago, the Chief Executive Officer charged Lazerick Johnson, an engineer currently assigned to the Goodlow Magnet School, 2040 West 62<sup>nd</sup> Street, Chicago, Illinois 60636, with insubordinate actions, including failure to carry out a rule, order or directive related to the performance of the employee's duty; inappropriate behaviors in the classroom or on school grounds or assigned work location, or which attendance school function; repeated or flagrant acts of Group 1 misconduct; repeated or flagrant acts of Group 2 misconduct; forgery or falsification of official school documents; theft or unauthorized possession of school property, or use of such property for unauthorized purposes; behaviors that seriously disrupt the orderly educational process in the classroom, in the school, and may occur on or off the school grounds or assigned work location; repeated or flagrant acts of Group 3 misconduct; conduct which is cruel, immoral, negligent, criminal or causes psychological or physical harm or injury to a student; violation of School Rules or Board Rules, policies or procedures which result in behaviors that grossly disrupt the orderly educational process in the classroom, in the school, and may occur on or off the school grounds or assigned work locations; appropriate and unauthorized use of Chicago Public Schools computers and internet services; conduct unbecoming a Chicago Public Schools' employee.

The Chief Executive Officer hereby requests the dismissal of Lazerick Johnson from the employ of the Chicago Board of Education. Lazerick Johnson has been afforded a discharge hearing and the Chief Executive Officer has suspended Lazerick Johnson without pay.

He will be dismissed from employment immediately upon service of the notice of dismissal together with a copy of this Board Report and the charges and specifications.
