

REPORT ON STUDENT EXPULSIONS FOR MARCH, 2003**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

117 Students were expelled from the Chicago Public Schools in March 2003.

DESCRIPTION:

Pursuant to the provisions of Sections 10-22.6 and 34-19 of the *School Code of Illinois*, Section 6-8 of the *Rules of the Board of Education of the City of Chicago*, and the *Uniform Discipline Code* of the Chicago Public Schools, the Chief Education Officer approved the expulsion of the following 117 Chicago Public Schools students, listed below, identified by their student identification numbers, for gross disobedience, misconduct or other violations of the bylaws, rules and regulations of the Chicago Board of Education.




