**AUTHORIZATION TO PURCHASE 6725 SOUTH HERMITAGE FOR THE  
CONSTRUCTION OF A NEW MILES DAVIS ACADEMY**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Authorize the purchase of the property at 6725 South Hermitage for the construction of a new Miles Davis Academy. The authority granted herein shall automatically rescind in the event a written agreement is not executed within 120 days of the date of this Board Report. Information pertinent to the purchase is as follows:

**DESCRIPTION:** 1,350 square foot, single family, frame residence on a 3,050 square foot lot in West Englewood. PIN: 20-19-405-014.

**PURCHASE PRICE:** \$77,000 + \$5,000 Owner's Relocation Payment + Moving Expenses.

**PURPOSE/USE:** To acquire property for the construction of a new Miles Davis Academy.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the written agreement. Authorize the President and Secretary to execute Agreement. Authorize the General Counsel to execute all ancillary documents required to administer or effectuate this agreement.



Indebtedness: The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.




