

**APPROVE THE PARTICIPATION OF LAKE VIEW HIGH SCHOOL IN PARIS TRAVEL/STUDY TOUR  
AND AUTHORIZE TRAVEL OR OTHER EXPENSES RELATED TO THE PROGRAM**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve the participation of fourteen (14) Lake View High School students in an educational tour to Paris, France from March 29 through April 5, 2007.

**PROGRAM:** The eight day trip is a culminating activity for students who have demonstrated academic achievement in French and their other courses. Prior to the trip orientation meetings with participants will take place once a month to familiarize students with what they will see and experience. Students will be introduced to the "City of Lights" with a ride up the Eiffel Tower and a boat tour down the river Seine. They will visit major museums, monuments, and neighborhoods: Monet's home in Giverny, the Louvre museum, Musée d'Orsay, Versailles Palace, Arc de Triomphe, Notre Dame Cathedral, Montmartre, Musée Picasso,, Beaubourg, Quartier Latin, the Marais, the flea market, and of course a French fashion show at the Galeries Lafayette department store. Many of the students who are French Club members have been corresponding with our sister city school Lycée Albert Schweitzer just outside of Paris. We will have lunch with the students upon arrival and explore Paris in the afternoon with these French teens.

**EDUCATIONAL VALUE/OUTCOMES:** There is no greater value than traveling and experiencing another culture. The students will improve their language skills because they will be surrounded by French and have the opportunity to use it on a daily basis. They will interact with French people of all ages from all walks of life: teens from the Lycée Albert Schweitzer, workers in our hotel and the metro, servers in cafes and restaurants, and salesmen and women in the shops. Our Lake View students will come away from this experience more confident with an expanded understanding of themselves and the world around them.

**TRAVEL ARRANGEMENTS/TRIP INFORMATION:** Arrangements for this program are being made by Prometour Inc. 339 rue St. Paul East, Montréal, Québec, H2<sup>^</sup> 1H3, Canada.

**COST:** The per pupil/person cost is \$ 2,150 which includes transportation, meals, hotel costs, health and accident insurance, trip cancellation insurance, etc. The costs will be paid by participants.

**CHAPERONES:** Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel"), including proper ratio of students to adults. Traveling with students will be: 1. Donna Chen, Teacher, Group Leader 2. Julie Schwartz, Co-Leader and long time community volunteer 3. Elynn Prorise, Assistant Principal at Lake View

**PARENTAL CONSENT:** Written parental consent and release forms for each student/persons are on file at Lake View High School.

**AUTHORIZATION:** Authorize the President and Secretary to execute any travel agreements necessary for this program.


