PROGRAM: To assist CPS high school students enrolled in the Chinese World Language Program in further developing into global citizens, the Office of Language and Cultural Education, through a federal grant, is sponsoring a Chinese Summer Language and Culture Institute in Shanghai China. Classes will be held at East China Normal University. Students will be participate in daily language classes and weekly cultural activities designed to enhance Mandarin Chinese language skills.

EDUCATIONAL VALUE/OUTCOMES: The Office of Language and Cultural Education (OLCE) believes that all students should have the opportunity to experience and develop an appreciation for languages and cultures beyond their own. The Chinese Summer Language and Culture Institute will enable student participants to strengthen their Mandarin Chinese language skills as well as experience the culture and heritage of the people of China. The skills and knowledge gained through the CSLCI, CPS students will strengthen their Mandarin Chinese language proficiency and also be able to provide presentations to their respective school communities on the importance of language learning and cultural immersion.

COST: The per pupil cost of this trip is \$4,650. Trip costs include airfare, visas, room and board, land transportation, tuition, and activity fees. Costs will be covered through grants from the United States Department of State and the Motorola Foundation.
