

**APPROVE MODIFIED RESTRUCTURED SCHOOL DAYS AND SCHOOL CALENDAR
AT SELECTED ATTENDANCE CENTERS**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That the Board approve modified restructured school days and school calendar at selected attendance centers. With the modifications noted herein, these calendars will be different from the 2007-2008 regular and year-round school calendars approved in Board Reports 07-0523-ED19 and 07-0523-ED20.

DESCRIPTION: The 55 Schools listed on the attached under CATEGORY A wish to have additional Restructured Days added to their calendar. The school day is restructured so that the school may provide in-service training programs and other staff development activities for teachers without falling below the minimum hours of instruction required by the Board of Education and the Illinois School Code. These schools wish to restructure the length of the instructional school day to allow them to schedule various in-service and other staff development activities for their teachers. In order to do this while still providing the requisite number of instructional hours, the school has proposed that additional minutes be added to each day. The extra minutes that are accumulated by these schools allow one or more additional shortened school days to be scheduled, with the remaining time reserved for staff development activities.

Board Rule 6-22 provides that the specific hours of operation of each attendance center may vary to reflect the scheduling needs of each school. All schools are required to maintain regular hours of operation that provide all students with a minimum of 300 minutes of instructional work per day. These schools have submitted calendars that have been thoroughly reviewed to ensure that students receive the minutes of instruction as required by Board Rule 6-22 and the Illinois School Code.
