

AMEND BOARD REPORT 07-1219-PR6
**APPROVE EXERCISING THE REMAINING OPTIONS TO RENEW THE PRE-QUALIFICATION
STATUS OF AND THE AGREEMENTS WITH CONTRACTORS FOR VARIOUS TRADES WORK OVER
\$10,000 FOR THE OPERATIONS AND MAINTENANCE PROGRAM**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the remaining options to renew agreements with and the pre-qualification status of contractors for various trades work over \$10,000 for the Operations and Maintenance Program at a cost for the extension term not to exceed \$20,000,000 in the aggregate. Written extension agreements for each contractor are currently being negotiated. No payment shall be made to any contractor during the extension term prior to the execution of such contractor's written extension agreement. The authority granted herein shall automatically rescind as to each contractor in the event such contractor fails to execute the extension agreement with 120 days of the date of the Board Report. Information pertinent to this extension is stated below.

This amended Board Report is necessary to i) correct the contractor name for number 94 and ii) to add two (2) new contractors to the pre-qualified pool (identified as numbers 108 and 109) on the attached list (Specification No: 04-250197C). Written master agreements for each new contractor are currently being negotiated. No services shall be provided by any contractor and no payment shall be made to any of them prior to the execution of their written master agreement. The authority granted herein shall automatically rescind as to each new contractor in the event such contractor fails to execute the Board's master agreement within 120 days of the date of this amended Board Report.

ORIGINAL AGREEMENTS: The original agreements (authorized by Board Report 05-1221-PR5), as amended (authorized by Board Report 06-0426-PR7 and 06-0628-PR4) are for a term commencing January 1, 2006 and ending December 31, 2006, with the Board having the option to extend the pre-qualification period and each master agreements for (2) two additional one (1) year periods. The original agreement was extended (authorized by Board Report 06-1220-PR4), as amended (authorized by Board Report 07-0425-PR1 and 07-0926-PR1) for various terms, all ending December 31, 2007. The Board is not renewing its agreements with 7 following vendors; they have been deleted from this pool: Accurate Environmental Solutions Inc., I&N Asphalt & Concrete Company, Indigo Construction Services, Inc., Industria, Inc., J&Y Electrical Contractors, Mamax, Inc, and Najlia International, Inc. The original agreements were awarded on a competitive basis pursuant to duly advertised Request for Qualifications (Specification No.: 04-2501970 & 04-2501970A).

OPTION PERIOD: Each agreement is being extended for a term commencing January 1, 2008 and ending December 31, 2008.

OPTION PERIDS REMAINING: There is no option period remaining.

TERM FOR NEW AGREEMENTS: The term for the agreements with the two new contractors, Indigo Construction Services Inc. and Frank Cooney Company, shall commence March 1, 2008 and end December 31, 2008, with no option to renew.

SCOPE OF SERVICES: Contractors will continue to provide various trades/work for the O&M Program for projects over \$10,000 at all Chicago Public Schools.

DELIVERABLES: Contractors will continue to provide labor, material and supplies for the O& M Program for projects over \$10,000.

COMPENSATION: The compensation payable to all Contractors during the first extension term shall not exceed \$20,000,000.00 in the aggregate.

USE OF THE POOL: The Department of Operations, self-directed schools, and/or the board's property management consultants shall cause bid solicitations to be issued to the pre-qualified contractors for the types of services as needed. Bid will be awarded to the lowest, responsive, responsible contractors and notices of award will be issued by the Chief Purchasing Officer. All awards and any change orders thereto will be subsequently presented to the Board for approval.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written extension agreements and new master agreements. Authorize the President and Secretary to execute the extension agreements and new master agreements. Authorize the Chief Purchasing Officer to issue the Notices of Award connected with this O& M Program. Authorize Chief Operating Officer to execute all ancillary documents required to administer or effectuate the extension agreement and new master agreements.

AFFIRMATIVE ACTION: Pursuant to section 6.2 of the Revised Remedial Plan for Minority and Women Business Enterprise Contract Participation (M/WBE Plan), the M/WBE goals for this contract include 26% total MBE, and 5% total WBE. Aggregated compliance of the vendors in the pool will be reported on a quarterly basis.

GENERAL CONDITIONS:

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.


Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.






