

**DESIGNATE ALEXANDRE DUMAS ELEMENTARY SCHOOL AS A TECHNOLOGY MAGNET CLUSTER SCHOOL, CHANGE THE SCHOOL'S EDUCATIONAL FOCUS TO A TECHNOLOGY PROGRAM AND CHANGE THE SCHOOL'S NAME TO DUMAS TECHNOLOGY ACADEMY**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS:**

That the Board designate Alexandre Dumas Elementary School (unit # 6890), located at 6650 S. Ellis Avenue, as a technology magnet cluster school, change the school's educational focus to a technology program and change the school's name to Dumas Technology Academy.

**DESCRIPTION:** Effective July 1, 2008, Alexandre Dumas Elementary will (1) implement a technology program as its educational focus; (2) be designated as a technology magnet cluster school; and (3) undergo a name change and become Dumas Technology Academy (Dumas Tech or Dumas).

**Enrollment:** Implementation of a Technology Magnet Cluster program will have no impact on the enrollment status of students currently attending Dumas. Dumas will continue to serve students in grades PreK-8 and shall enroll students based on the school's existing attendance boundaries. Students wishing to enroll in Dumas Tech who reside outside the school's attendance boundaries must submit an application in accordance with the procedures established by the Office of Academic Enhancement. For the 2008-2009 school year, a special application process will be established by the Office of Academic Enhancement in spring 2008 to fill remaining spaces at Dumas Tech. If more applications are received than there are spaces available, students will be selected for the remaining spaces through a computerized lottery process.

**Curriculum:** Dumas Tech will provide its students with a Technology Magnet Program beginning at the kindergarten level. The Technology Magnet Program will work to systematically integrate technology throughout the core curriculum to not only engage the strengths, interests, and learning styles of students, but to also develop their advanced technology and 21<sup>st</sup> century skills. This will include enabling students to utilize technology to demonstrate creativity and innovation, communicate and collaborate with peers and experts, develop research and information fluency, think critically and problem solve, and understand the human, cultural and societal issues involved with living in the digital age. The integration of technology within the curriculum will be driven by the Illinois Learning Standards, National Educational Technology Standards, and the specific, evidence-based needs of the school. In particular, a special emphasis will be made on improving students' science, mathematics and writing skills through the use of problem-based units that incorporate technology as a learning tool.


**Academic Calendar:** Dumas will continue to follow the Chicago Public Schools' standard 10-month academic calendar from August to June with a summer school program in July and August. Teachers and educational support personnel may be required to commit to training and other activities outside of the academic calendar.

**School Day:** Dumas will continue to employ a closed campus model with a minimum teacher school day of 8:30 a.m. to 2:45 p.m. and a student standard school day of 9:00 a.m. to 2:45 p.m. Teachers and educational support personnel may be required to commit to after-school training and activities with students, staff and community. After-school programming will be established to provide tutoring, instructional activities, enrichment activities and/or social center activities to students.

**PERSONNEL IMPLICATIONS:** Board rules, policies, practices and collective bargaining agreements will govern any impact on positions and staff at the school.

**FINANCIAL:** CPS has received a grant from the United States Department of Education in the amount of \$11,729,261.00 to support the establishment of five new technology magnet cluster schools, including Dumas.
