THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Effective July 1, 2009, adjust the attendance boundaries and grade structure for the Frederick Funston Elementary School ("Funston") located at 2010 North Central Park Avenue, and the attendance boundaries for Ames Middle School located at 1910 North Hamlin Avenue.

A public hearing was held on October 16, 2008 at the Chicago Board of Education Chambers located at 125 South Clark Street to discuss the proposed boundary changes.

DESCRIPTION:

These changes are possible due to the declining enrollment at Funston. This will allow the Funston to serve kindergarten through eighth grade in two years. Beginning in July 2009, Funston will move from serving kindergarten through sixth grade to serve kindergarten through seventh grade. In July 2010, Funston will move from serving kindergarten through seventh to serve kindergarten through eighth grade.
