

**RELOCATE THE MCKINLEY PARK ELEMENTARY SCHOOL,  
ESTABLISH THE ATTENDANCE BOUNDARIES FOR MCKINLEY PARK ELEMENTARY SCHOOL,  
AND ADJUST THE ATTENDANCE BOUNDARIES FOR BRIGHTON PARK ELEMENTARY SCHOOL  
AND NATHAN DAVIS ELEMENTARY SCHOOL**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS:**

That the Board approve the relocation of the McKinley Park Elementary School ("McKinley Park") into the new facility at 3456 West 38<sup>th</sup> Street and establish an attendance area boundary for McKinley Park, effective July 1, 2010, and adjust the attendance area boundaries for Brighton Park Elementary School ("Brighton Park") located at 3825 S. Washtenaw Avenue and Nathan S. Davis Elementary School ("Davis") located at 3014 W. 39<sup>th</sup> Place.

A public hearing was held on August 21, 2009 at the Chicago Public School Board Chambers located at 125 South Clark Street discussing the relocation and proposed boundary changes.

**DESCRIPTION:**

Effective July 1, 2010, the McKinley Park will be relocated to the new school facility at 3456 West 38<sup>th</sup> Street. McKinley Park will begin the 2010-11 school year as a neighborhood school and serve approximately 900 students in grades Pre-K through eighth grade beginning in the 2010-2011 school year.

All the students in grades kindergarten through seventh currently attending McKinley Park or residing within the attendance area for the McKinley Park Elementary School and currently attending Brighton Park or Davis will be transferred to the relocated McKinley Park to commence their next school year in September 2010 at McKinley Park. Students who do not wish to attend the McKinley Park must apply for (re)enrollment at Brighton Park or Davis through the Board's Open Enrollment program. Enrollment at Brighton Park or Davis of students who reside outside the new attendance areas is subject to available space and other conditions as set out in the Open Enrollment provisions of the Board's Policy on Enrollment and Transfer of Students in the Chicago Public Schools (Board Report 08-0927-PO2). These changes are necessary in order to relocate McKinley Park while relieving the overcrowding in the area.

Pursuant to the Board of Education's Policy on the Review and Establishment of School Attendance Boundaries, 05-0622-PO1, a public hearing was convened on Friday, August 21, 2009, following the issuance of proper notice to receive public comment on the CEO's proposal to relocate McKinley Park and establish its attendance area boundary and adjust the attendance areas of Brighton Park and Davis. An independent hearing officer received oral and/or written comments and supporting documents at the hearing and kept the record open after the hearing to receive additional written comments or documentation. The hearing officer has prepared and submitted a report regarding the CEO's proposal in which the hearing officer recommends relocating McKinley Park and establishing attendance area boundaries for McKinley Park and adjusting the attendance area boundaries of Brighton Park and Davis. After receiving the hearing officer's report, the CEO has determined to recommend that the Board approve the relocation of McKinley Park, establish the attendance area boundaries of McKinley Park Elementary School and adjust the attendance area boundaries of Brighton Park and Davis beginning July 1, 2010.




