Application for Amendment (AFA) Overview

Background & Process:

- The AFA is an annual process for charter and contract schools to propose changes to their existing agreements that require approval from the Board.
- Applications submitted undergo a thorough evaluation conducted by the Office of Innovation and Incubation based upon the nature of the proposed amendment.
- Staff recommends two applications for approval based on an evaluation of performance standards.
