

Broken out by School Year




Student Leave Codes by Original Re-Engagement Outreach Tier


Number of students enrolled on 20th Day

Broken out by Race/Ethnicity







Year-Over-Year Students In and Students Out




Year-Over-Year Leave Code Usage

Student activity status or latest leave code as of October 22nd, 2021 and is subject to change. Only 23,467 students with a DNA (Did Not Arrive) status are included here. The DNA process excludes PE and PK students, and excludes students in Charter, some Options, State Pre-K, SSaS, Therapeutic, and Sped/Dual Enrollment schools, and in SY22 also Camelot SAFE schools. Thirteen student IDs that were deleted were also excluded. Two additional students were excluded with grade level PK and N/A, four additional students were excluded where the DNA was processed by mistake, and other students attributed to non-DNA Options schools were excluded.
