# Community Schools



## **CPS COMMUNITY SCHOOLS INITIATIVE**

Chicago Public Schools (CPS) manages one of the largest community school systems in the nation, known as the **Community Schools Initiative** (CSI) which supports 213 schools, 23,000 students, and 4,700 parents.

### **CSI Goals**

- Transform and maintain selected public schools to become the centers of their communities
- Connect children and families to a range of services that foster individual and economic well-being
- Counteract the effects of a range of negative factors that contribute to students' lack of opportunities and underachievement
- Engage parents and the community to improve academic achievement





## 21ST CCLC SCHOOLS – IMPACT EVALUATION

The most recent impact study (AIR, 2014) of the 21<sup>st</sup> CCLC schools (*not* SCS) did not show a direct impact on student academic outcomes, but it did show a direct impact on several student engagement measures:

#### **Grades K-3**

- Fewer misconducts
- Fewer suspensions

#### Grades 4-8

 Higher Emotional Health on 5Essentials survey

#### Grades 9-12

- Fewer unexcused absences
- Higher scores on 5Essentials survey:
  - Psychological sense of school membership
  - Inquiry-based science instruction
  - Student-teacher trust
  - Academic personalism

### SCS SY19 ACCOMPLISHMENTS: BUILDING THE FOUNDATION



Student Participation Goals: 3,225 students and 250 programming hours per Week Accomplishment:

- 4,438 students (138% of goal)
- 250 hours of programming (100% of goal)



Parent Participation Goals: 940 parent participants and 975 Parent Program hours Accomplishments:

- 2,304 Parent Service Hours (236% of goal)
- 553 parent participants (59% of goal)



## Capacity Building: Accomplishments:

- 8 days of professional development for school leadership teams; 3 for LPAs
- 2 full-time coaches reinforced PD and provided on-site support

### **SY19 SCS BUDGET: \$10M DISTRIBUTED ACROSS 20 SCHOOLS**

Each school receives \$500K annually, which is distributed across the six SCS pillars

### SCS: THIRD PARTY EVALUATION PLAN



**Initial Study - Implementation** 

- How well do SCS stakeholders understand the six pillars?
- To what extent are pillars being put into practice?
- Are pillars making a change in everyday school practice?
- Are SCS processes effective?

In partnership with the CTU, CPS selected SREed – Socially Responsible Evaluation in Education at the University of Wisconsin-Milwaukee – as a third party evaluator
