


Case Volume is now Only Slightly Higher than Last Year

Student Misconduct Accounts for Majority of SY20 Reports




Student Allegation Types from 9/3/19 – 4/24/20

Reports of Adult Misconduct from 9/3/19 – 4/24/20



2019-2020 Charter, Contract, and Options School Data Summary: 9/3/19 to 4/24/20



Title IX School Representative Training Sessions for Charter, Contract, and Options Schools

Training summer of 2019 - **100% compliance** with the District's commitment to having a trained **Title IX School Representative** at each Charter, Contract, and Options school by the start of the 2019-20 school year (SY20)

 CPS has trained 162 employees from 121 Charter, Contract, and Options schools on the appropriate way to respond to sexual misconduct concerns and on the mandatory reporting procedures.

As a result of these trainings, Charter, Contract, and Options schools are now better-informed on the types of sexual misconduct concerns and how to report them. This helps them understand how OSP can help their efforts to appropriately respond to sexual misconduct concerns.




Increased Reporting from Charter, Contract, and Charter Schools after Training from CPS

- Due to the training sessions in August 2019, sexual misconduct reporting from Charter, Contract, and Options schools (as a group) is **2.5x greater** in the 2019-20 school year (SY20) than at this point in the 2018-19 school year (SY19)
- At this point in SY19, Charter, Contract, and Options schools (as a group) had reported only **31%** as many incidents per capita as District schools
- So far in SY20, Charter, Contract, and Options schools have (as a group) reported **90%** as many incidents per capita as District schools



Case Volume for Charter, Contract, and Options Schools Has Increased in SY20


Cases Per 1,000 Students by Type of School



• Training sessions at Charter, Contract, and Options schools resulted in reports increasing by 2.5 times year-over-year. This increase took place despite the school closures starting on 3/17/20 that caused a slight year-over-year decline in reporting from District schools.



Charter, Contract, and Options Schools Reports Per Capita are Nearly Equal to District Overall




- **Elementary Schools:** Reporting from Charter, Contract, and Options schools now slightly exceeds District reporting.
- **High Schools:** District reporting is still 1.5 times greater than reporting from Charter, Contract, and Options schools.
