Objective 1: Generate ideas for SQRP 3.0 stakeholder engagement opportunities for March 2020 and beyond

Objective 2: Engage attendees on their feedback for values and uses of school performance information and related topics



Level-Setting

Historical Context:

- CPS is required by state law (dating from the mid-1990s) to have a locally defined school rating system. SQRP is the current policy defining that system, having succeeded the Probation, Remediation and Performance Policy (PRPP) in the 2014 school year.
- Section 5/34-8.3 of the Illinois School Code requires that the district establish the standards and criteria for issuing a School Quality Rating and Accountability Status to each school that is either Good Standing status, Remediation status (which indicates the need for Provisional Support) or Probation status (which indicates the need for Intensive Support).
- The SQRP ratings that released in Fall of 2019 marked the sixth time schools were rated under the original SQRP. In Fall 2020 schools will receive rating for the first time under a revised system (SQRP 2.0).
- In addition to these requirements, the district strongly believes there is value in measuring and reporting school quality indicators to support families understanding how their children are being served and to help ensure ALL students have equitable access to great schools.

At the June 2019 Board meeting (when the above noted revisions were passed), the Board gave district staff a clear mandate to design the next iteration of the district's accountability system (SQRP 3.0). Stakeholder engagement is a critical aspect of this process and we need your help to make that effective.

Stakeholder Engagement Work To Date

Complete:

• The district developed a stakeholder survey that was released in sync with the November 20th 2019 CPS Board meeting.

In Process:

- American Institutes for Research (AIR) Focus Groups: CPS is collaborating with AIR to conduct six focus groups during the upcoming public budget meetings. This will provide high-quality, rigorously analyzed information about stakeholder values and opinions. (January-February)
- **Student Voice Committees (SVCs):** CPS's Department of Civics and Student Engagement is connecting with the SVCs to get feedback from approximately 150 middle school students and 60 high school students.
- **School Engagement Protocol:** CPS's Office of Equity is developing a school engagement protocol to guide in-school engagements supporting a sensitive dialogue with an array of stakeholders while prioritizing communities most impacted by inequity.
- Community-Based Organizations (CBOs): CPS's Office of Family and Community Engagement is working to convene CBOs to offer feedback and partnership in developing SQRP 3.0.





What do our stakeholders find important? (4,023 Respondents)

Metric	Share of Respondents who Ranked the Metric as Top 3 in Importance
School Climate and Culture (As measured by student and teacher surveys.)	36.0%
Student Growth (Improvement on standardized tests.)	31.9%
Student Attainment (Knowledge at a single point in time measured by standardized tests.)	23.7%
Course Performance (Measured by 3-8 On Track for Elementary Schools, Freshman on Track for High Schools.)	21.1%
Student Readiness to Transition to College or Career (High Schools only.)	22.0%
Attendance	19.4%
Data Quality (Valid, reliable and consistent data reporting fit for use in operations, decision making and planning.)	17.5%
Student Support and Retention (Measured by Dropout Rate.)	13.5%
English Language Proficiency (Measured by an Individual Proficiency Exam.)	4.7%
